CONTRACT SPECIFICATION	
Description	<p>The MIRECS Spot Products listed on Appendix 10F represent a standardized, cleared contract for immediate (“spot”) physical delivery of renewable energy certificates issued in the MIRECS registry.</p> <p>RECs acceptable for delivery are those having been generated by a renewable source and held in the MIRECS registry and having a Generation Month in the range listed on Appendix 10F for the applicable MIRECS Spot Product.</p>
Clearing & Settlement	<p>Asset Units associated with Products that are the subject of Transactions are pre-cleared and physically settled through the Market Operator’s Payment versus Delivery Clearing and Settlement structure. Asset Units are delivered on a spot basis (intra-day based on netted end of day positions) into the Participant’s Market Registry Account, an account exclusively dedicated for use in connection with the Market.</p>
